

Income Tax Law (No. W. R.
16 of 1957):

I wish to remind all persons who received their Regional Income Tax Assessment Notices by 31st January, 1958, that they must complete payment not later than 31st March, 1958. This applies both to persons who have already paid half their tax within two months of receiving their Assessment Notices and who are now due to pay the balance and to those who have not yet paid anything.

2. If any of these persons fail to complete payment in time, legal action may be taken against them. Some persons have already incurred penalties for not paying at least half their tax within two months of receiving their Assessment Notices and they have received Demand Notes accordingly. I remind them that the total demanded must be paid within 30 days of receipt of the Demand Note.

3. I have power to grant extensions of time to individuals but I shall only do so where very good cause is shown.





The entrance examination to the above College will be held on Saturday, 9th August, 1958, at centres in Warri, Benin Abraka and elsewhere as may be necessary.

Two classes will be admitted for the two year Grade II Certificate Course.

Letters requesting application forms must reach the Principal before 31st May. All applications must be submitted through sponsors. Private Candidates will not be admitted.

Only Grade III teachers in at least the second year of certificated service, or School Certificate holders or pupils in the final year of a Secondary Grammar School course are eligible.

Before admission, successful candidates will be required to produce proof that they have signed an Agreement with an Employer to teach in Schools in the Western Region on completion of the course.

**Public Notice
 Payment Of Tax By
 Money Orders**

With effect from 1st April, 1958, the charges on Money Orders used for payment of Western Region Income Tax will be met by Government.

2. An individual taxpayer who wishes to remit his tax by Money Order to an Income Tax Office will be issued with a Money Order free of commission charges if he produces to the issuing Post Office Official his Assessment Notice or Demand Note. If the amount shown on an Assessment notice may be paid in 2 instalments a Money Order for half the amount due may be obtained. The amount shown on a Demand Note must be paid in full. The Money Order will be payable only to the Commissioner of Inland Revenue at the station from which the Assessment Notice/ or Demand Note was issued.

3. An employer who is making deduction from staff salaries may similarly obtain such money orders if he produces at the post office the Tax From 7.

4. The maximum for which an Inland money order can be issued is £50, so if the amount of tax is greater than that more than one money order will be required.

5. All such money orders must be crossed for payment only through a Bank.

6. Postal orders will NOT be issued free of postage.


