Ministry of Education, Western Region GOVERNMENT TRADE TRAINING CENTRE, SAPELE.

1. An entrance examination for admission to the Government Trade Training Centre, Sapele will be held on 9th June 1956.
2. Trainees will be selected from this examination for full-time residential courses for Motor Vehicle Mechanics (4 years), Painters and Decorators (3 years) and Woodcutting Machinists (3 years). Other courses may be available later in the year.
3. The entrance examination will consist of written papers in English and Arithmetic; there will also be tests in general knowledge and sketching. There will be examination centres at Akure, Ibadan, and Abeokuta.
4. To be eligible to sit for the examination, all of the following conditions must be complied with:-
 - (a) Boys must not be more than 17 years of age and not less than 15 years of age on 1st July 1956.
 - (b) They must have been born in or attended school in the Western Region or be of Western parentage.
 - (c) They must possess a Primary VI School Leaving Certificate.
5. Application forms to sit the examination must be obtained from the Principal, Government Trade Centre, Sapele. The completed forms must be returned to the Principal to reach him not later than 8th May 1956. Each application form must be accompanied by:-
 - (a) An examination fee of 2/6d, in the form of a Treasury Receipt (Postal Orders, Money Orders or cash will not be accepted for the examination fee).
 - (b) A photograph (2" x 2") of the applicant's head and shoulders.

Forms which are received without the Treasury receipt, or which arrive after 8th May 1956, will not be accepted. The examination fee is not returnable.

6. Applicants who comply with the above conditions will be notified by the Principal, and informed of the time and place to attend for the examination.

7. Candidates who attend for the examination are required to bring with them:-

- (a) A Birth certificate or sworn declaration of age. (A Baptismal certificate is invalid for this purpose).
- (b) Their Primary VI School leaving Certificate.

Candidates who are unable to submit evidence of the required age and educational qualifications are warned that they will not be admitted to the examination.

8. Candidates who are successful in the examination will be notified when and where they will be required to attend for personal interview, but such candidates should note that final selection for admission to the Trade Centre will not be made until after interviews have taken place.

9. Fees are £7. 10. 0d. per annum and are payable in advance each year.

10. It is likely that the number of suitable candidates will exceed the number of vacancies available and while consideration will be given to the preference of the selected candidates, it should be clearly understood that they must be prepared to accept whatever trade course may be offered.

11. General conditions for admission and regulations can be obtained from the Principal, but no reply will be sent to letters addressed to the Principal on the subject of the acceptance or rejection of any candidate.
