No. 19. Introduction: By The Minister of Social Services

The Syllabus for Infants' Schools has been revised to improve the standards of instruction concerned, with the introduction of free primary education in Lagos. The object of the new Syllabus is to help teachers to guide school children from the very beginning of their careers, not only in the basic elements of formal instruction, but also in critical appreciation and awareness of life in all its aspects.

1. Children should enjoy learning, and they can do so only if their interests are aroused and maintained. To many children in the past, learning has been a dull drudgery, solely because their latent abilities have been left to wither away in the dull atmosphere of repetitive exercises in rote Nigeria school-trained pupils, who can think for themselves, must be shown the light, by teachers who must be qualified.

2. This Syllabus, which has been revised with great care and with particular regard to its application to the thousands of young pupils now entering our schools, will, it is hoped, start a new era in the right lines. It will be used for a five-year period of two years and, finally, accepted if it is found to be satisfactory in practice.

3. I am grateful to the Syllabus Committee and Sub-Committee for their careful and thoughtful work in preparing this Syllabus and I wish every success to all those to whom it has been prepared.
