## Pastor King Fights Colour Bar In America

GEORGIA, U.S.A.—The Reverend Martin Luther King, Negro civil rights leader, recently released from jail against his will, said he will remain here to continue his protest against racial segregation practices.

Dr. King and a fellow minister chose jail rather than pay a fine for violating a local ordinance. They had served two days of a 45-day term when the fine was paid by an unidentified man and they were released.

Shortly after his release, Dr. King said he would remain here until city officials agree to drop charges pending against some 750 demonstrators arrested since last December, when a dispute began over racial discrimination in bus and rail terminals, and until officials establish a biracial committee to discuss desegregation of public facilities here.

Dr. King said "some progress" was made but no further conferences had been scheduled. Dr. King said he "could not in all good conscience, leave here until these cases have been resolved."

Pastor of local Church, Dr. King achieved world-wide attention several years ago for his role in fighting—and eventually eliminating—racial segregation on buses in Montgomery, Alabama. He is now President of the Southern Christian Leadership in Georgia, America.
