NURSING AND MIDWIFERY TRAINING IN THE UNITED KINGDOM.

With reference to Government Notice No. 1527, published in the Nigerian Gazette No. 61 of the 29th of October, 1953, it is notified for public information that it is now no longer necessary for persons domiciled in Federal territory who wish to proceed to the United Kingdom for nursing and midwifery training at their own expense to apply to the Students' Advisory Committee (Nursing) in order to seek admission into a suitable training hospital in the United Kingdom.

2. Prospective nursing students are free to make their own arrangements direct with the hospital of their choice, and to apply direct to the Principal Immigration Officer for a passport on obtaining a firm offer of admission from the hospital.

3. Matrons of hospitals in the United Kingdom have been informed that in future they should use their own discretion in accepting or rejecting candidates for admission.

4. The Students' Advisory Committee (Nursing) of the Ministry of Natural Resources and Social Services, Lagos, will, however, continue to assist Matrons, if so required by them, in checking references, experience, educational qualifications etc., of prospective candidates and arranging for the medical fitness of candidates to be ascertained.

5. Prospective students are advised to communicate with the British Council Representative, 25, Ajasa Street, Lagos (Telephone, Lagos 21521) before leaving Nigeria in order that they may receive advice on their requirements and conditions of living in the United Kingdom, and make arrangements for their reception in the United Kingdom.

The attention of all persons engaged in teaching in the Western Region is drawn to Sub-section (2) of Section 61 of the Education Law, 1954.

No person shall teach in any institution in the Region unless he has been enrolled on the register of teachers or his name has been removed from such register or during any period of suspension."

Principals, Managers, Headmasters or Principals, whatever is appropriate, should apply for Form W.R.Ed 9 stating the TOTAL NUMBER OF PERSONS engaged in teaching in institutions under their control (this includes everyone from probationary to supervisory staff). Applications for forms should be made to:

(1) The Senior Education Officer of the Province in respect of persons employed in PUBLIC primary or secondary modern schools;

(2) The Registrar, Ministry of Education, Western Region, Ibadan, in respect of persons employed in all other institutions.

Notwithstanding the provision of Sub-section (5) of Section 61 all teachers in the Western Region are required to complete the form.

Teachers employed in institutions should obtain their application forms (W.R.Ed. 9) from their Headmasters or Principals. Qualified unemployed teachers who are genuinely seeking employment as teachers may obtain application forms from either the Senior Education Officers or the Registrar. No person should apply prior to his first appointment as a teacher, such application should be made through the Headmaster or Principal of the institution in which appointed.
