# Lagos Town Council PUBLIC NOTICE

## Lagos (Conservancy) Bye-Laws, 1958.

The attention of the general public is hereby drawn to the fact that in the Civil Suit instituted against the Lagos Town Council by the Nightsoil Removers' Union, the Federal Supreme Court has now ruled that the Council's Conservancy Bye-Laws are quite in order.

The Lagos Town Council therefore wishes to notify the general public that following the Supreme Court's ruling, the Lagos (Conservancy) Bye-laws, 1958, have now been validated.

It should be noted that bye-law 3 vests in the Council the sole right of removing nightsoil from all premises in Lagos Island, and that under the provisions of bye-law 4, owners and occupiers of premises are barred from securing the services of private nightsoil-men for carrying out this work. Finally, bye-law 7 makes it a punishable offence for anybody to contravene the provisions of any of the bye-laws.

The Municipal Treasurer will shortly be sending out bills for Conservancy fees which will show all arrears together with charges for the quarter ending 31st December, 1958. In view of the ruling of the Federal Supreme Court arrears must be settled without further delay.
