When a License is issued after April 1st and before July 1st, or on or after July 1st and before October 1st or on or after October 1st a reduction of one quarter, or one half or three quarters of the above fees may be allowed respectively.

"Weight" means the weight of the Vehicle exclusive of the weight of any water or fuel.

Moorhouse, C.M.G., D.S.O., fi iwe No. L.C 10/1915 sowo si awon ti o f' ori fun Ijoba yi, ti nwon si je asaju enia dada; ese keji iwe na wi bayi pe:—

"Gomina ri esi gba si iwe re ti o fi mu iwe gbe yin ti o lo ni ogun oṣu November 1915 lo, a si ni ki nso fun o pe akowe agba ni on ko tun je ba o soro na mo."

Ni soki eyi ni itan ti ibi, iwalaaye ati kiku Egbe People's Union, asaju awon eniti akowe agba ti o ntoju ilu amona Geni so fun ninu oṣu August 1915 "pe iṣe eniti o ba di ogun Ijoba mu ni lati kokp terita fun awon oṣin ilu re."
