

AGBE, JAIYEOLA.

Auctioneer & Valuer, aged 42, born at Lagos, eldest surviving son of the late Thomas W. D. alias Daddy Agbe of Epe, District Lagos educated St. Peter's and Christ Church Faji Day School, at the C. M. S. Grammar School, 1808-99. Served as a junior law clerk under the renowned late Honorable C. Alexander Sapara Williams, C. M. G. and subsequently entered the Lagos Government service as a Telegraph learner in 1901; is an accomplished Telegraphist, serving in dual capacity as District Clerk, Yoruba interpreter and Deputy Registrar, Benin City, 1905-6. Served in Agbo-Owerri Punitive Expedition as operator for Column when District Commissioner Mr. Cewe was murdered; was mentioned in despatch as Political Officer Mr. R. A. Roberts, now Senior Head Ouitsha Province and acting; Leuit: Governor, promoted to first grade Superintendent Clerk Temp in March, 1908. Holder Clerical Service Pass Certificate 1912 Resigned in 1914, and proceeded to England, returned home in 1915 December. Was a man at Pitman's College, London. Proceeded to Lagos again in April, 1921, to acquire practical and theoretical knowledge in auctioneering business; is a regular student of the National University of Dublin, Ireland in the Faculty of Law; attended series of lectures on Roman Law, Constitutional Law & Legal History & Law of Property in Michealmas Term, 1921. Has passed the Entrance Examination for the admission of students to the Irish Bar; is holder of commendable letters from Professor James Munaghan and M. McNeill M. P. Not having been born with a silver spoon in his mouth, has experienced many vicissitudes of life. His first contribution to local newspaper was "A cry from Macedonia," in 1911. I have read with contempt page 5 of the fair copy of the *Nigerian Advocate* bearing the date of Oct 17, relative to a case between Sadiku Olowonla, a native of Ikorodu, and Sergeant Samui Bushman of the Police Force Stationed at Ikorodu. As a true citizen of that place, I consider it a negligence of duty to let this inaccurate information to remain uncorrected.

Judgment was against the Defendant for £5 damages only and no costs as inserted by the writers in that journal. The writers further pretend to vindicate the interest of the citizens by adding that report has

each them to the effect that untried prisoners at Ikorodu are kept to hard labour instead of light work of sweeping the prison compound &c. allowed by the law.

Are the writers truly patriotic? Were they not alive in 1922 when things were actually out of order and jails not granted in the afternoon? Why the writers do not refer to the cases of so many citizens who have been ruined by means of false Promissory Notes etc. Are they interested? I can assure the Commissioner of Police without any hesitation that the citizens are content with the virtuous movements of the Police now situated at Ikorodu and that the story contained in that journal is as virulent as it is worthless.
