- Holy Trinity Church, Bonny was formerly Opened and Dedicated by the Right Reverend Superintendent S.

A. Coker on Sunday the 10th September at 9 a.m.

The procession from the old place of worship to the New Building, the route taken being about a quarter of a mile singing Hymn 373, was a sight worth seeing and never to be forgotten. Mr. Bowar Brown directing movement. A very suitable and impressive sermon was preached by the Right Rev. Superintendent.

The Building ordered out from England costing about £1000 was the gift of one of the Chiefs. The cost of the whole work including furniture was about £2000. Delegates from all the Churches in the Bonny Division were present in the afternoon, the Pastor Rev. A. I. W. Hart was presented by the Delegates of the whole District to the R. Rev. Superintendent to be installed a Superintendent Bishop or Overseer (New Testament of the District). This was very solemnly performed. The special sermon by the Gen. Superintendent from i Peter v:4 was very instructive and helpful, a sermon such as he could preach. This service, the Gen. Superintendent has ordered to be translated into the different languages of the Division for the benefit of all.

Owing to some Congregations having split from Christ Army Church, yet designating their Church Christ Army and approval of the Gen. Superintendent, and in order to avoid confusion, litigations and wrong impressions in Political offices and the public generally, have very regrettably renounced the name Christ Army Church, retaining the original alternative Niger Delta Native Congregational Church. The work of the Organizing and General Superintendent S. A. Coker in Yoruba and in the Niger Delta is now co-ordinated under the general designation The United African Congregational Church of which Superintendent A. I. W. Hart is a Superintendent and in Charge of the Bonny Division under the Gen. Superintendent.

A SENSATIONAL POLICE CASE AT IKORODU.

A sensational police case was tried in the District Court of Ikorodu before A. R. W. Sayle Esqre, District Officer and Commissioner of the Supreme Court on Monday the 15th instant when Mr. A. O. Dolo-Dossum, M.A., appeared for the plaintiff and Mr. A. Kayode, B.A., LL.B., H.L., appeared for the defendant. One Sergeant Sami Bashorun who is the Head of the Police Detachment at Ikorodu was sued by one Sadiku Olowonisiye for "Malicious Prosecution and False Imprisonment" was found guilty and judgment was given against the Police Sergeant for £5 although the Plaintiff's claim was £50 damages.

The decision in this case is very important because it shows that even in Nigeria where the Police seem to have unbounded powers of arrest still they cannot tamper with the liberty of the subject in cases where they are not protected by the law of the County.

This is a matter which may be taken as a sample of the way some Policemen are in the habit of abusing their official powers and it is hoped that the other subordinate officers of the police department will have this as a lesson and refrain from making use of His Majesty's Uniform to intimidate and overreach the people in Ikorodu. It is also hoped that the Police Authority will take steps to keep a constant watch on their detachments of police in the Districts as the tendency for them is to go beyond bounds when they are away from headquarters and it is only natural that the integrity and honour of the Police Force cannot go on calling for respect if acts like this be condoned and let pass by the higher Authorities.

We are glad to note that the decision in the above case is in keeping with the tradition of the English Court of Justice where the judges will not hesitate to decide against officials of Government whenever they do any act in excess of their legal authority.

We take our hats for Commissioner Sayle for this important decision.
