FACTS AND FIGURES.

A Letter From London.

We are publishing the following extracts from a letter we received last mail from a friend in the interest of our youngmen.

The letter *inter alia* says:—

"By the way, is your intention to tour round Europe still holding? I am dying to meet you here. Travelling is educative and is worth the money and time consumed. But to us Africans a European tour is disastrous. For, born and bred under a foreign government we have been educated to despise our own customs and institutions and regard our masters' as the ideal. With such a temperament we travel into European countries. And a pity, their vices have more fascination for us than their virtues. As a result, returning home, we try to yoke together two incompatible elements—European and African—and consequently lose our identity or individuality as a nation. In fact what we are, in our *dual state* we ourselves cannot define. There is one name which can be applied to such types of people—*Europeanismaniacs*. This may not be a happy nomenclature, but it can serve practical purposes. These maniacs are a menace to the nation. They have dangerously polluted the African atmosphere and the mass has been their victim. In language, custom and everything the tendency is to embrace anything European whether good or bad. Why must we wear European dress in an African Country? Why must we speak an odious blend of English and African languages? Or Pidgin English? Even our Education is *English and un-African*. The madness of intermarrying with Europeans is another step in the precipitating course. Viewed from an economical as well as racial standpoint, it is most disastrous thing to do. I wonder why our fathers don't remonstrate against such dangerous unions. They are always found inarticulate when circumstances necessitate their shouting from the house-top. It seems they have lost their sway and paternal influence over youth and are afraid to make a public protest. But this matter is not individual but national and hence we need their interference.

In England girls who marry Africans become *Social Outcasts* and I see no reason why boys guilty of such crimes should not be ostracised and made ineligible to have hands in national societies.

But alas, the whole system has run riot.

Now Roman is to Roman
More hateful than a foe
And the tribunes beard the high
And the fathers grind the low
Therefore men speak not frankly as they did

In the brave days of old "

This youth is only a specimen of many a Nigeria's son in London who has been fired with genuine patriotism and is anxious that a great deal of useful works is done in the interest and welfare of the race. We cannot but join our esteemed townsman Mr. Henry Carr (in his address to the Union of Nigerian Students) in the hope that when all these young patriots come back home they will not leave behind them in London all the good resolutions they have formed for the promotion of the welfare of our country.
